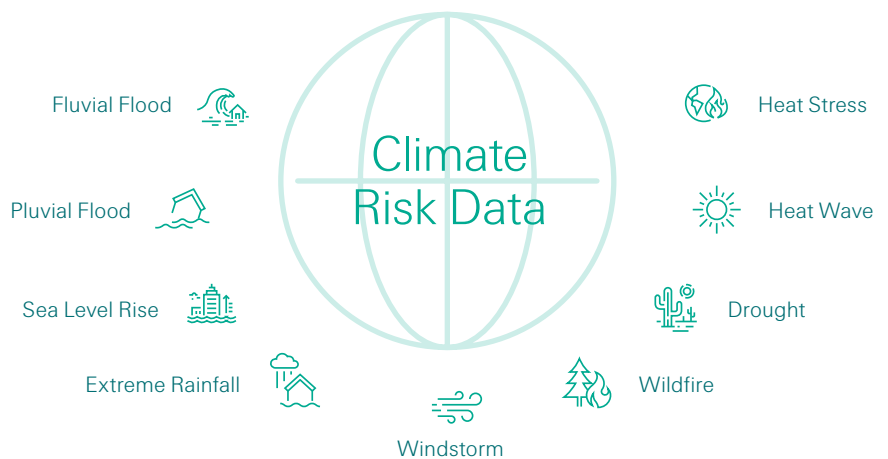

Climate Risk Data

Simplify climate assessment with 9 **Climate Risk Scores** developed by Swiss Re. These data scores, based on IPCC AR6 science, show trends of future hazard development over 5-year intervals from 2030 to the end of the century for three scenarios: SSP1-2.6 (sustainability scenario), SSP2-4.5 (middle of the road scenario) and SSP5-8.5 (fossil fueled development scenario). Combining the Climate Risk Scores with the present risk exposure, the **Future Hazard** categories provide a holistic view of the risk to plan adaptation measures.

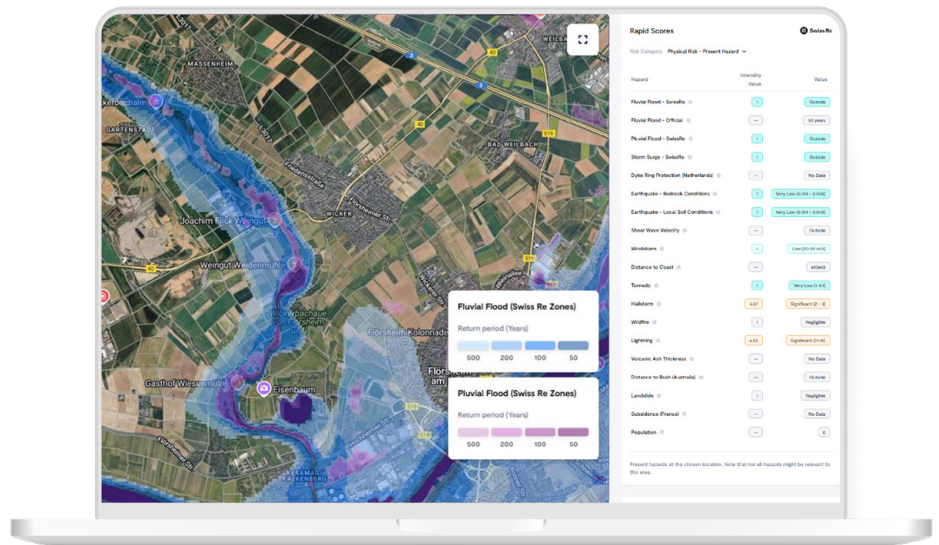
